SFL ran 1,000 conferences for more than 40,000 attendees in FY16.

(Revenue \$) Leadership Programs - SFL's emphasis on leadership development has been the key to the organization's success over the years. SFL teaches young people entrepreneurship, event-planning, volunteer management, effective writing, public speaking, and other skills that they can use throughout their lives, and gives them experience applying these skills in building the student movement for liberty. SFL trained 2,758 student leaders that engage with thousands of student groups across the world.
